Maintenance update – Cory Bull

- Update from Cory on applicability of tax within the Alpha Paving quote. Tax is correct. Completed.
- Update from Alpha Paving (Dirk) Van Landuyt who attended the meeting in person.
 - O Dirk explained that the airpark would need to be closed several times during the crack fill and seal coating. Dirk will also canvas the Airpark and provide the Board a map of where asphalt would be recommended for replacement. Dirk also recommended we not start until Spring time for better results on the seal coating and crack filling. The quote for work from Alpha Paving does not include "alligatoring" areas, which would be an extra cost.
- Update from Cory re: terminal/club house building lights being replaced.
 - o Completed.
- AGED 2 MONTHS Update from Cory on separate quote for the total cost of new asphalt for RWY, TAXI and RAMP so that the Board can plan for future outlays.
 - Dirk will provide a quote to Cory for the replacement of all the asphalt so that the Board can plan for that cost. 561,000 sq. ft. is the total estimated size - Cory
- New "No Parking" signs (2) are needed to be ordered for the auto lane at the entrance of the Airpark. Josh Cobb will order them for installation Josh
- Jeff explained that he had obtained new Texas Fuel Pump stickers and would applying them to the pump Jeff
- Cory explained that he had replaced four (4) tie down ropes on the ramp.
